**PARTICIPANT RELEASE OF LIABILITY**

**BY SIGNING THIS AGREEMENT, YOU ARE ASSUMING ALL RISK IN PLAYING IN HAPCO SOCCER AND ARE WAIVING IMPORTANT RIGHTS. ENSURE THAT YOU READ AND UNDERSTAND THIS AGREEMENT BEFORE SIGNING. IF YOU DON'T UNDERSTAND, THEN OBTAIN INDEPENDENT PROFESSIONAL ADVICE. NO ONE AFFILIATED WITH HAPCO SOCCER IS AUTHORIZED TO ADVISE ANYONE AS TO THE MEANING OF THIS AGREEMENT OR WHETHER YOU SHOULD SIGN THE AGREEMENT.**

In consideration of being allowed to participate in any way in Hapco Soccer, Inc. ("Hapco Soccer") and related events and activities, I the undersigned, acknowledge, understand and agree that:

1. The risk of injury and damage from the activities involved in this program is significant including, without limitation, the potential for contracting disease (e.g. COVID-19), permanent paralysis and death.
2. **I KNOWINGLY AND FREELY ASSUME ALL RISKS, BOTH KNOWN AND UNKNOWN INCLUDING, WITHOUT LIMITATION, ARISING OR RELATED TO THE NEGLIGENCE OF THE RELEASEES AND/OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION.**
3. I willingly agree to comply with terms and conditions for participation. If I am aware of any material or significant hazard and/or violation of terms and conditions for participation, then I will immediately remove myself from participation and bring such awareness to the attention of Hapco Soccer and its representatives. I will not return to participate in Hapco Soccer until I am completely satisfied that the hazard and/or violation has been remedied.
4. I, for myself and on behalf of my heirs, assigns, personal representatives, next of kin and anyone claiming by or through me, **HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS** Hapco Soccer, its officers, officials, agents, employees, and other participants, sponsors, advertisers, as well as owners and lessors of the premises (and their officers, officials, agents, employees, and other participants, sponsors, advertisers) used to conduct Hapco Soccer games and events and activities ("Releasees"), from any and all claims, demands, losses, and liability arising out of or related to any **INJURY, DISABILITY, DEATH, LIABILITY OR CLAIM, LOSS OR DAMAGE TO PERSON OR PROPERTY THAT I MAY SUFFER OR HAVE, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.
5. I acknowledge, understand and assume the risks, if any, arising from the conditions and use of the fields, facilities and related premises, whether as a participant or a spectator, including without limitation, the risks involved with participating in Hapco Soccer's activities. I further acknowledge and understand that included within the scope of this waiver and release is any cause of action (including any cause of action based on negligence) arising from the performance, or failure to perform, maintenance, inspection, supervision or control of said activities and/or areas and for the failure to warn of dangerous conditions existing during such activities and/or at said facilities, as well as for negligent selection of certain Releasees, or negligent supervision or instruction by Releasees.
6. I acknowledge, understand that Hapco Soccer reserves the right to photograph facilities, activities and program participants for potential future use. All photos remain the property of the Organization and may be used for publicity and promotional services.
7. The Releasees shall be intended third party beneficiaries of this agreement and may enforce its terms against any claimant as if a party thereto. No variation of this agreement shall be effective unless it is in writing and signed by the parties. This agreement constitutes the entire agreement between the parties related to its subject matter, and supersedes any previous agreement (whether written, oral or implied) between the parties.
8. The failure of either party to exercise in any respect any right provided for herein shall not be deemed a waiver of any further rights hereunder. If any provision of this Agreement shall be adjudged by any court of competent jurisdiction to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this agreement shall otherwise remain in full force and effect and enforceable.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
